ENROLLMENT NOTICE

Dear Resident or Small Business:

In March 2012, Village of Fredericktown voters authorized by majority vote the creation of an Electric Aggregation Program to seek lower electricity rates for eligible residential and small business customers. The Village of Fredericktown selected Constellation Energy Services, Inc. to supply electricity to the Village Electric Aggregation Program. As a resident or small business owner of the Village of Fredericktown, you are eligible to participate in this program.

You will be automatically enrolled in the program unless you opt out by August 24, 2015.

How You Benefit

The Village of Fredericktown has negotiated a competitive price of **\$0.0634/kWh.** This pricing will be effective from your first meter read on or after September 29, 2015 through your August 2017 meter read. Please see the enclosed Terms and Conditions for full details.

Important things to remember

- ✓ Call (855) 713-4487 if you have any questions.
- ✓ If you do nothing, you will automatically be enrolled in the Village of Fredericktown Program.
- ✓ AEP will continue sending monthly bills, responding to outages, and delivering your electricity.
- ✓ No one from the Village of Fredericktown program will ever come to your door to ask you to switch to a new supplier. Anyone who comes to your door asking you to switch is not with the aggregation program.

Billing and Service Unchanged

Other than the price and supplier, nothing regarding your electricity service will change. You will continue to receive one monthly bill from AEP Ohio. AEP will continue to deliver your electricity, restore power following an outage, and be responsible for maintaining the system that delivers power to your home. its generation service charges for this aggregation program, please note that if you are currently on budget billing with AEP Ohio, the utility may bill you for any balance owed to them at the time of enrollment. This may result in a charge or a credit from AEP, depending on the current status of your budget billing accumulation. To set up budget billing with Constellation, please call our customer service center at (855) 713-4487.

Please note: Constellation will bill you for your actual energy supply charges (rather than any budgeted amount) until you have contacted us to set up your budget billing account. Your budget billing with AEP will automatically continue for all other portions of your AEP bill other than the energy supply component if you are currently enrolled with AEP Ohio for the same.

Enrollment Information

After your enrollment is finalized, AEP Ohio will send you a letter confirming your enrollment. As required by law, this letter will inform you of your ability to rescind your enrollment without penalty.

How to Opt Out

If you do not wish to participate in the Village of Fredericktown Electric Aggregation Program, you must opt-out by August 24, 2015. To opt out, return the enclosed postcard. You may also opt-out by contacting Constellation toll-free at (855) 713-4487 or online at www.constellation.com/oh-fredericktown. If you do not opt-out you will be enrolled in the Village of Fredericktown Electric Aggregation Program. At the end of this current program term in August 2017, you will again be provided with an opportunity to opt-out of the Village's Aggregation Program, or you may terminate the agreement at any time without penalty per Section 10 of the Electricity Purchase and Sale Terms and Conditions.

Tax Exempt Customers

Tax exempt customers should send their most recent tax exempt certificate on or before August 24, 2015 to: Constellation Energy Services, Inc., 1716 Lawrence Drive, De Pere, WI 54115 or fax to (920) 272-4244. Be sure to note "Village of Fredericktown Electric Aggregation Program" and your utility account number on the certificate. Constellation will cease collecting sales tax beginning with the date the certificate is received.
