Dear Sample Customer,

In November 2015, Village of Tuscarawas voters authorized the creation of a natural gas aggregation program. Your community selected Constellation Energy Services – Natural Gas, LLC (Constellation) as the preferred supplier for its natural gas aggregation program through January 2019 meter read cycles. You have the following rate options, which can be canceled at any time. Option 1: Fixed Rate - This includes a fixed rate of \$3.398 per Mcf. Option 2: Monthly Variable Rate -NYMEX settlement price for the relevant month’s natural gas, converted to Mcf using the Utilities then current Btu factor, plus an “Adder” of +\$0.107/Mcf.

**You’re Automatically Enrolled**

There is no cost to enroll. As an eligible customer, you are automatically enrolled in Option 1 unless you decide to opt-out or call Constellation to enroll in Option 2. For either option, please see the enclosed terms and conditions for full details regarding the rate and other terms of the program. You may terminate this Agreement without penalty at any time for any reason by providing notice to Constellation.
